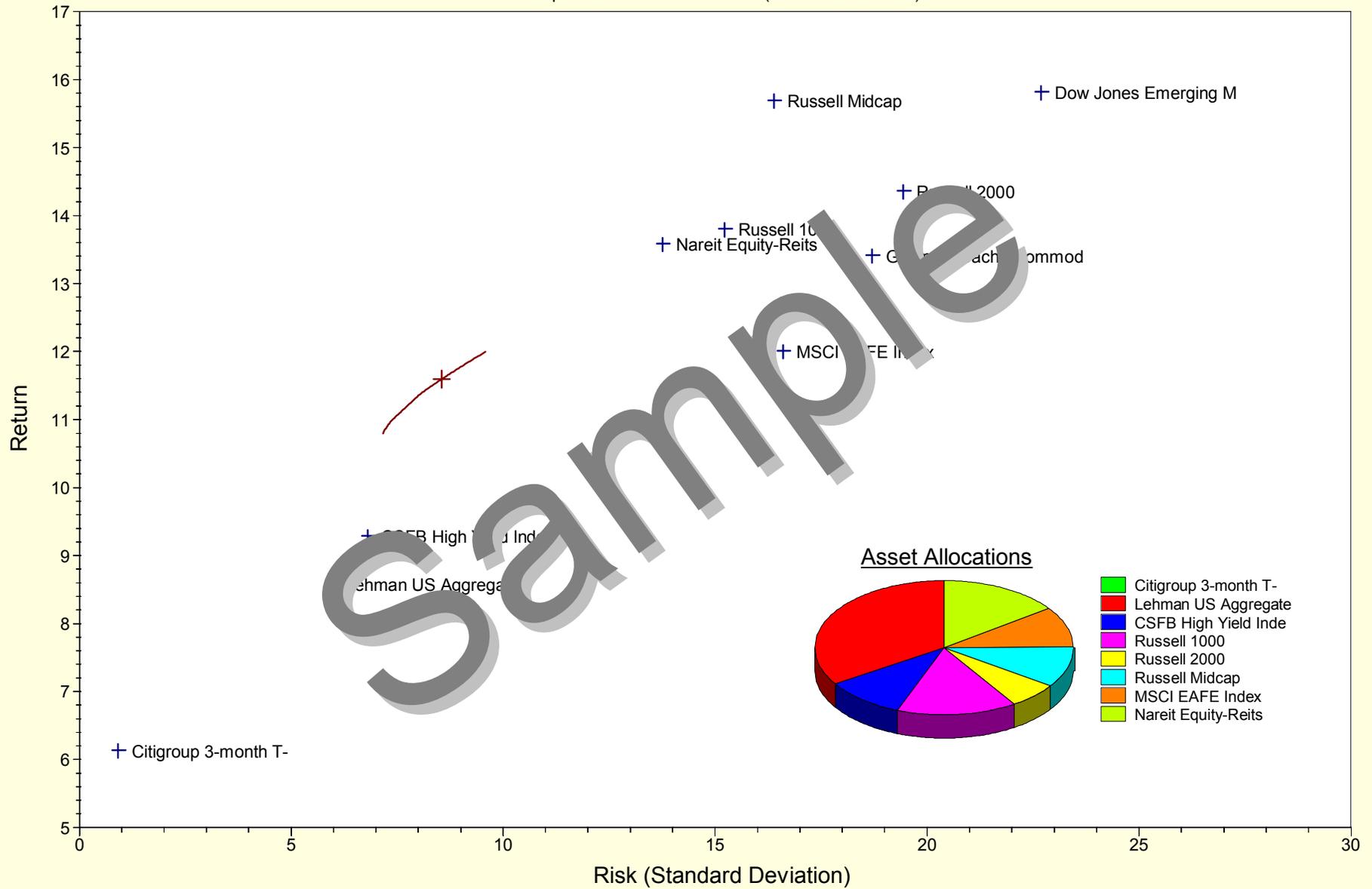

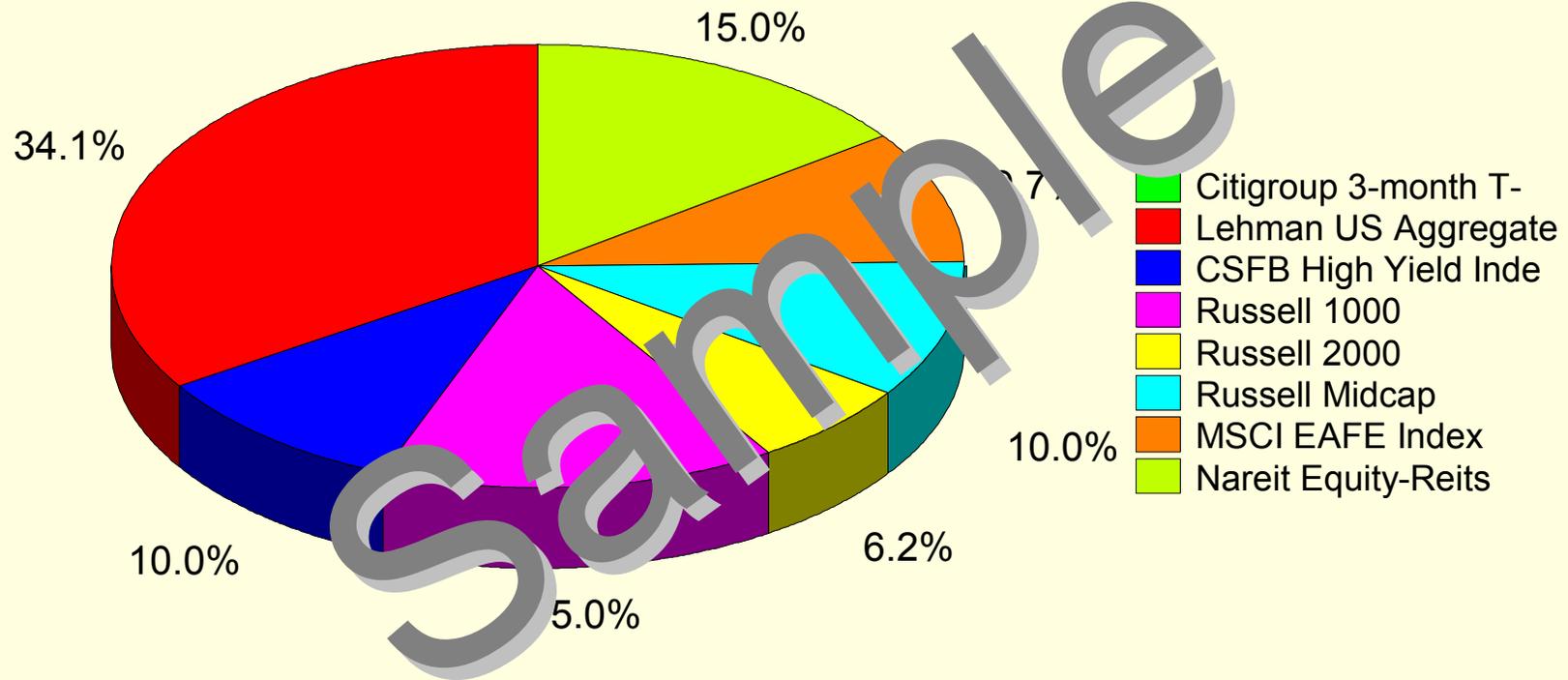

Case: Sample Case    Percent of Portfolio



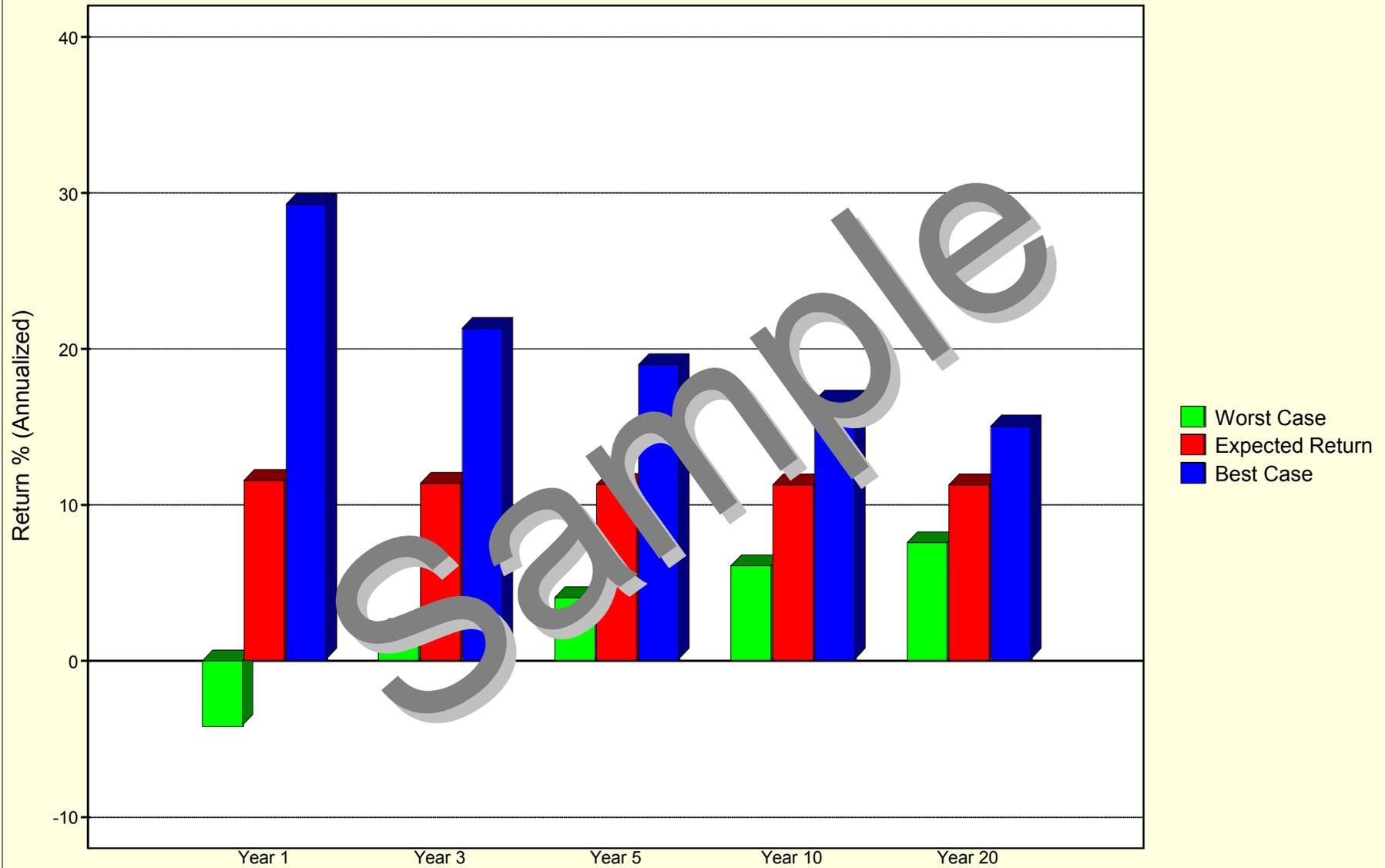
